Use the ONLINE BILL PAYMENT option available through major banks such as:



Royal Bank





Once you receive your Tax Invoice in the mail, logon to your preferred Online Banking site, once there follow the below steps:

- 1) Search for "HAPPY" in payee section
- 2) Select the appropriate payee for the Town and Click "Add Payee"
- 3) Type your "Municipal Account Number" (add 5 zeroes to make your Account # a total of 11 (eleven) digits required by your bank). Example: 12345600000
